Household of Prince William, Duke of Gloucester 1689-1700

From his birth in 1689, the Duke of Gloucester was assigned a few servants (wetnurses, rockers) on the establishment of his father and mother, the Prince and Princess of Denmark. At the death of Mary II, William earmarked £10,000 for the Duke of Gloucester. Tough Parliament allotted £50,000 per annum for the establishment of the Duke of Gloucester's household in 1697, William III decided in July 1698 to dole out only £15,000 per annum out of the Civil List for that purpose. This began LD last to be paid to Sir Benjamin Bathurst, treasurer, without account, apart from the sums owed to the Earl of Marlborough as governor.¹

Below, the draft establishment of [?Aug.] 1697 has been taken as authoritative, but it should be understood that most of the Duke's household servants were not sworn in until a year later.
